# **Prince George Resident New ABCFP President**

This year's president is Christopher Stagg, Registered Professional Forester, of Prince George, BC.

The 69<sup>th</sup> council includes forest professionals from around the province who have a variety of backgrounds that will enhance the work of the ABCFP. This year's council includes representatives from government, large forest companies and independent consultants.

The ABCFP council governs the affairs of the association and works to fulfill the ABCFP's mandate as defined in the *Foresters Act*. The ABCFP council is made up of 10 elected councillors and two lay councillors who are appointed by the provincial government.
